2. Ginette Gagnon – Skootamatta Lane

Ginette Gagnon attended the meeting as a resident of Skootamatta Lane to speak to the increased traffic and speeding occurring on the lane. Gagnon requested an O.P.P. presence in the area to help alleviate the speeding issue. Gagnon also requested that the Municipality investigate using the former railway line to Price Road, instead of the entire Skootamatta Lane, as a by-pass to reduce traffic on the laneway. Gagnon also requested that the Hawkins Bay Bridge be repaired and/or replaced in order to alleviate traffic on Skootamatta Lane.

3. Grant Roughley – North Frontenac Telephone Company

Grant Roughley of the North Frontenac Telephone Company attended the meeting at the request of Council to provide details about high speed fiber optic internet in the Village of Tweed. Mr. Roughley requested that council sign an access agreement with the North Frontenac Telephone Company to allow them to lay fiber optic cables through the Village of Tweed. The access agreement would allow the North Frontenac Telephone Company to move forward with a feasibility study of bringing fiber optic internet access to the Village. Council asked questions of Mr. Roughley regarding road maintenance after cuts have been made in the asphalt to install the fiber optic cables. Mr. Roughley confirmed that the access agreement will ensure and provide a mechanism to ensure all parties are satisfied with the work being completed underneath municipal infrastructure.
